Signs in violation of the below Codes will be collected and taken to the City Public Works Facility at 2055 Mizell Road where the candidates can pick up their signs and the candidate will be contacted. Further violations will result in punitive actions.

Since St. Augustine Beach City Hall is a polling location, signs are only allowed on City Hall property, not the public right-of-way, during an active voting period. The following applies during this period:

- Signs cannot be placed more than seven (7) days before the start of early voting and must be removed within seven (7) days following election day.
- Signs must be placed 100 feet or more from any City Hall entrance.
- Parking spaces can only be used for parking a motor vehicle.

For signs placed within the limits of the City of St. Augustine Beach:

Signs in violation of the below Codes will be collected and taken to the City Public Works Facility at 2055 Mizell Road where the candidates can pick up their signs and the candidate will be contacted. Further violations will result in punitive actions.

The following applies throughout the City limits:

- Signs can only be placed with the permission of the property owner.
- Signs cannot be nailed, fastened, affixed to, or painted on any tree or part thereof (living or dead), or other vegetation.
- Signs cannot be attached to a seawall, dock, buoy, tie pole or pier.
- Signs cannot obstruct, conceal, hide, or otherwise obscure from view any traffic control device sign or official traffic signal or be placed on the poles or supports of such devices.

**A temporary sign displayed on a window surface must be displayed on the inside of the window surface, shall cover no more than twenty-five (25%) of the window surface, and shall not be illuminated.

Vehicle Signs:

Vehicle signs cannot exceed 40 square feet on any vehicle and the following is prohibited:

- a. Vehicles not "regularly used in the conduct of the business".
- b. Vehicles visible from a street right-of-way within fifty (50) feet of the vehicle.
- c. Vehicles parked for more than two (2) consecutive hours in any twenty-four (24) hour period within fifty (50) feet of any street right-of-way.
- d. Vehicles shall not be considered "regularly used in the conduct of the business" if the vehicle is used primarily for advertising.
- e. This provision is not to be construed as prohibiting the identification of a firm or its principal products on a vehicle operating during the normal hours of business; and which is currently licensed, insured and operable; provided, however, that no such vehicle shall be parked on public or private property with signs attached or placed on such vehicle primarily for the purpose of advertising a business establishment or firm or calling attention to the location of a business establishment or firm.
